

Which LPA?

There are two types of LPA which can be made in England and Wales.

These are the Health (for decisions about healthcare provision) and Financial (for decisions about your property and finances) LPAs.

Proving Mental Capacity

As the Donor (the person making the LPA), you must be over 18 years of age and have the mental capacity to make an LPA.

Otherwise, the LPA will not be valid or effective.

All our online and telephone services are designed to show you had the mental capacity at the time of making your LPA.

However, there can sometimes be circumstances which give rise to doubts over whether someone has the requisite level of capacity.

We work with an experienced medical practitioners and specialist capacity assessors who can meet with you and provide a report on your capacity.
